Brakes	Front		Must be fully operation, prevent wheel from turning when applied & free of leaks
	Rear		Must be fully operation, prevent wheel from turning when applied & free of leaks
Wheels & Bearings secure			Wheel must be secured, nuts tight & spokes secured. Bearings must be free from excessive movement & wear on all wheels & steering head.
Machine # plates GCR 11.12.1			Plates must be fitted to front & both sides of the bike with clear readability of the numbers as per GCR's for entered class.
Handlebars & levers- GCR 11.18.6			The ends of the handlebars or twist grip sleeves must be securely plugged to present a flush or rounded end. Must have bar pad fitted. Levers must have ball ends.
Chain guards GCR 11.18.8			A chain guard must be fitted as to prevent trapping between the lower drive chain run and rear sprocket.
Kill Switch GCR 11.18.6.6			All machines must be fitted with an effective ignition cut-off switch located on the handlebars.
Foot Rests GCR 11.18.5			Must be rounded and free of sharp edging, hinged or pivoted with spring return.
Side Stands GCR 11.18.4			Must be removed or secured in the closed position
Throttle GCR 11.18.6.3			Throttle controls must be self-closing and free.
Exhaust/Silencer GCR 11.18.3			Must have silencer fitted & system secured as per GCR's.
Helmet –GCR 11.11			Must comply with FIM standards with approved label/sticker fitted
Boots – GCR 11.11			Must be of leather, plastic or durable material & cover ¾ of lower leg with boots & pants over lapping.
Gloves & Goggles GCR 11.11			Gloves of leather or other material of similar or greater durability.
Pants & Jersey GCR 11.11			Must be long pants & sleeved and of close knit fabric & of close fitting.
Body Armour – Jnrs GCR 11.11			Commercially manufactured upper body protection (front and back) must be worn.
